COVID GUIDELINES

Arrival

- 1. Students may enter the building in time for their classes. Please arrive no more than 5 minutes prior to your class time. Students under the age of 9 must have a parent bring them upstairs to be dropped off in the hallway (parents with children age 5 & younger may sit in the lobby during their child's class)
- 2. Staff, students & parents must wear a mask in the building at all times and will use hand sanitizer upon entering.
- 3. Temperatures will be checked upon entry.
- 4. Please bring as few items into the studio as possible and keep all items in your own personal dance bag.
- 5. The onsite water fountain and microwave will be off limits at this time. Bring a large water bottle & food will be limited to healthy granola or protein bars & must be eaten in the kitchen.
- 6. All hard surfaces will be sanitized between classes. Please see the "studio schedule" on www.newenglandschoolofdance.com for sanitizing times.

Dismissal

- 1. Parents should arrive on time to pick-up students from the back, parking lot. Students will be walked outside of the building by a staff member. Non-driving students must be released to a parent / guardian known to the studio. Please email or call us if someone else will be picking up that day.
- 2. We also ask that parents meet students at the back door instead of waiting in their cars so we can ensure all students are picked up safely.
- 3. Dancers may only be in the studio when they are attending their registered classes. All other dancers must leave the studio at the conclusion of their class.

Illness Procedures

- 1. We ask that you follow the same protocol as public schools and please notify us of any potential symptoms. If you are experiencing symptoms such as fever, runny nose, sore throat, cough, shortness of breath, muscle aches or chills please stay home and email the office. If the symptoms continue or worsen after 24-hours please get tested and present the results to NESD via email or hard copy.
- 2. Please, notify us & do not come to the studio if you or someone you have been exposed to has COVID, or had COVID-like symptoms, within the past 10 days.
- 3. Dancers who test positive for COVID-19 must remain home until they have been cleared by a doctor and must provide documentation.

Traveler/visitors to AND **residents** of NH need to self-quarantine for 10 days following the last date of any travel internationally (including to/from Canada); on a cruise ship; or domestically outside of the New England states of Maine, Vermont, Massachusetts, Connecticut, or Rhode Island for non-essential purposes.

- If the person is asymptomatic and has a negative PCR test on or after day 7 of quarantining, they may shorten or end their quarantine.

 This 7-day "test out" of travel quarantine option applies ONLY to travel-related quarantine and NOT
- quarantine due to other types of exposure.
